DIRECTIONS FOR USE:

General Disinfectant: For use as a disinfectant on ordinary surfaces use 20 mL per 10 litres of water (400 ppm). For use on a porous surface or an area difficult to clean, use 40 mL per 10 litres of water.

Sanitizer: Can be used as a wash for pregnant sows prior to farrowing, cleaning dairy utensils, as an udder and flank wash, teat-cup rinse, dipping hatching eggs (immersing eggs in water maintained at 43EC - 49EC for 3 minutes) at a level of 10 mL per 10 litres (200 ppm). For sanitizing hatchery equipment, use 10 to 20 mL per 10 litres.

Poultry Drinking Water: For use in automatic proportioners, prepare

4 litres of stock solution containing 180 mL of Germex. Set proportioner to deliver approximately 30 mL per 4 litres of drinking water (65 ppm)

- 1. Remove all poultry and feeds from premises, trucks and coops, crates.
- 2. Remove all litter and droppings from floors, walls, and surfaces of facilities occupied or traversed by poultry.
- 3. Empty all troughs, racks and other feeding and watering Appliances.
- 4. Saturate surfaces with recommended solution.
- 5. Ventilate buildings, coop and other closed spaces. Do not house poultry or employ equipment until treatment has been absorbed, set or dried.
- 6. All treated feed racks, mangers, troughs, automatic feeders, fountains and waterers must be thoroughly rinsed with potable water prior to reuse.
- 7. If soap is used in the cleaning process, rinse thoroughly before disinfecting.
