GENERAL INFORMATION: DES-I-CATE is a liquid, water-soluble,

contact type herbicide for killing potato vines. In addition to facilitating harvesting, DES-I-CATE assists in setting potato skin, helps prevent late blight infestation and kills many weeds.

DIRECTIONS FOR USE: To avoid the possibility of foaming, fill tank with water and then add DES-I-CATE. Apply to potato vines 10 to 14 days prior to harvest using the recommended rates of DES-I-CATE thoroughly mixed with water as follows:

Light Vine Growth: Apply 17 - 22 litres of DES-I-CATE per hectare. Use higher rate during cool (less than 219 C) cloudy weather.

Medium to Heavy Vine Growth: Apply 22 litres of DES-I-CATE per hectare. With heavy vine growth use the full rate of 22 litres per hectare and spray to thoroughly wet lower stems. In situations involving very heavy top growth, double spraying, first up the field then down the rows on the same day with 11 litres/ha each time to give a total of 22 litres/ha, will maximize coverage and kill.

NOTE: No wetting agent or emulsifier is needed with DES-I-CATE. Do not use high rate under conditions favourable for rapid vine kill such as low soil moisture or high temperatures since stem end discolouration may occur.

Thorough coverage of all parts of the plant, stems and leaves, is essential for satisfactory topkill. For best results spray at a Pressure of 700 - 1050 kPa using 500 - 800 litres of water per hectare.

PRECAUTIONS: Wear goggles, rubber gloves, rubber boots, overalls, rubber apron, and a respirator when handling. KEEP CHILDREN AND ANIMALS OUT OF TREATED AREA UNTIL IT IS DRY. Do not store near seed, feed or foodstuffs.

CAUTION: Avoid contact with or drift to other crops, trees or plants as injury may occur. Wash out sprayer immediately after use to facilitate ease of cleaning. Toxic to fish. Do not contaminate any body of water by direct application, cleaning of equipment or disposal of wastes and containers.
