THIS CONTAINER CAN BE REFILLED USING THE "JRS FILLER " USE ONLY THE JAAB TOTAL RELEASE INSECTICIDE BULK REFILL. (REG. NO.25875 PCP ACT) FOLLOW REFILL INSTRUCTIONS ON BULK REFILL LABEL.

NON-GAS AEROSOL. Delivers a quiet, even spray without using CFC or hydrocarbon propellents. All net contents are available for use, unlike a normal aerosol where a large percentage is propellant that is lost to the atmosphere and serves no other purpose than propelling product from the container.

DIRECTIONS: (1)To continuously spray, close all doors and windows. Place can in upright position on floor of empty van or container. Point valve away from eyes. Depress valve and lock in open position. Exit from van or container and keep the doors and windows closed for 30 minutes. Ventilate van or container for 4 hours before re-entry. Use two cans containing 220 mL spaced well apart in vans or containers over 50 cubic metres. (2) When manually spraying, container can be held in any position, even upside down to spray insects in the most difficult to reach areas.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Do not remain in treated areas. Ensure proper ventilation after areas have been treated Do not swallow or inhale. Avoid contact with skin and eyes. Wash after using. CONTENTS UNDER PRESSURE. Do not spray into or near any open flame, spark or while smoking. Wear a respirator with an organic vapor removing cartridge with a prefilter approved for pesticides (MSHA/NIOSH TC-23C) and eye protection at the start of total release application and if re-entering closed areas (Eg. for ventilation purposes).

FIRST AID TREATMENT. If sprayed in eyes, flush with clean water. If sprayed on skin, wash with soap and water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical attention at once or contact a poison control center. If inhaled, remove from site of exposure.

Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

DISPOSAL: When container is empty and you do not want to refill it again, wrap and dispose in household garbage.
