DIRECTIONS: Before adding chlorine solution, the pH should be tested and adjusted to within 7.4 to 7.8. Add muriatic acid if pH is high. Add soda ash if pH is low.

Chlorine solution should be added daily to maintain 0.5 to 1.0 parts per million available chlorine. the use of a test kit is recommended, as the air temperature and the number of people in the pool will affect the amount of chlorine solution required.

Under average conditions, chlorine solution should be added daily to pool water according to the following chlorination guide:

Pool Capacity
(Litres)

Daily Chlorine Solution
Charge (Litres)

10,000	125 - 250 ml
20,000	250 - 500 ml
50,000	625 ml - 1.25 L
100,000	1.25 L - 2.50 L
250,000	3.25 L - 6.25 L

NOTE: First application should be double the indicated amount.

Every three weeks, add one week's charge of chlorine solution in one application to ensure proper control of algae, slime and fungus. Avoid using pool until chlorine residual drops below 2.0 p.p.m. (approximately 24 hrs.)

CAUTION: KEEP OUT OF REACH OF CHILDREN. NEVER MIX WITH OTHER POOL OR HOUSEHOLD CHEMICALS. Do not put chlorine solution in aluminum or silverware containers. Avoid contact with skin and eyes. May be fatal or harmful if swallowed. Store only in original container, tightly closed, in a cool, dry place away from heat and sunlight, in an upright position.

FIRST AID TREATMENT: Contains Sodium Hypochlorite. If splashed in eyes or skin, flush thoroughly with water. If swallowed give one or two glasses of milk or warm water. Call Physician immediately, Keep patient warm.
