THIS CONTAINER CAN BE REFILLED USING THE "JRS FILLER". USE ONLY THE JAAB CRAWLING INSECT KILLER BULK REFILL (Reg. No.: 25586) FOLLOW INSTRUCTIONS ON BULK REFILL LABEL.

NON-GAS AEROSOL. Delivers a quiet, even spray without using CFC or hydrocarbon propellents. All net contents are available for use, unlike a normal aerosol where a large percentage is

propellant that is lost to the atmosphere and serves no other purpose than propelling product from the container. Container can be held in any position, even upside down to spray insects in the most difficult to reach areas.

DIRECTIONS: For use as a spot treatment to control insects listed on front panel. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vaporize into cracks and crevices for insect control. If reinfestation occurs, repeat applications as necessary. This product can also be used with an injection tube for injecting product directly into cracks and crevices where insects may be hiding, living and breeding. Place injector tip 2 cm into cracks, crevices, holes and other small openings where insects may be a problem. Release approximately 1 second spray per spot in serious infestation, if possible, place spots approx. 30 cm apart. In light infestation or preventive treatment place spots approx. 1 meter apart. See additional directions below for effective control of specified insects. Provide adequate ventilation after indoor use. **DO NOT ALLOW PERSONS OR PETS TO CONTACT TREATED AREAS UNTIL SPRAY HAS DRIED.**

INDOOR USE: CRAWLING INSECTS - Cockroaches, Crickets, Earwigs, Millipedes, Sowbugs, Spiders and Brown Dog Ticks: Spray into hiding places such as cracks and crevices, moist areas, opening around pipes and sinks and behind baseboards. Spray directly on insects in these locations where possible. Silverfish: Spray cracks and crevices in baseboards, door frames, book cases, and storage areas. Spray directly on insects in these locations where possible. Ants: Spray into trails, nests and points of entry around doors, windows, structural cracks and crevices. Spray directly on insects in these locations where possible. Thoroughly treats spots along and behind baseboards, underneath furniture and equipment, around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen. Brown Dog Tick and Fleas: Spray the infested areas such as pet beds and resting quarters. Old bedding should be removed and replaced with a clean, fresh bedding after treatment. This product is not for use on pets. For effective control pets should be treated with a registered flea and tick control product designed for use on pets.

OUTDOOR USE: Spray spots on outside surfaces of screen frames, doors, window frames, foundations, patios, light fixtures and other places where crawling insects may congregate and enter.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed, inhaled or absorbed through skin. Avoid contact with eyes, skin or clothing. **DO NOT USE ON HUMANS, PLANTS, ANIMALS, FOODSTUFFS, FOOD UTENSILS, FISHBOWLS OR ANIMAL FEED AREAS.** Do not use as a space spray or use on furniture. May cause skin and/or eye irritation. Product is very toxic to fish. Do not contaminate water by improper use or disposal. Remove pets and fish bowls from area before treatment and do not return for 4

hours. Do not apply to surfaces that children or pets might contact. DO NOT CONTAMINATE FOODSTUFF. Do not use in any area where food may be exposed. Do not use in bulk food storage areas. Do not use in cupboard where food or cooking utensils are stored. In home or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash with potable water all surfaces that might contact food before reuse. In food processing plants and food service establishments apply only when plant is NOT in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operation. In hospitals do not use in nurseries or rooms where infants, ill or aged persons are confined. Contents under pressure. Do not heat, puncture, or incinerate containers.

FIRST AID: If swallowed, DO NOT induce vomiting. Call physician or poison control centre immediately. In case of contact with the skin, wash with soap and water. If in eyes, flush with water 15 minutes, get medical attention.

DISPOSAL: When container is empty and you do not want to refill it again, wrap and dispose in regular garbage.
