The microcapsules provide a "timed release" mechanism for the chlorpyrifos active ingredient to provide up to 90-day control of adult fleas and larvae. Also kills many other household insects (see Directions for Use).

DIRECTIONS FOR USE

SHAKE WELL BEFORE AND AFTER MIXING

Directions for use: To prepare "Duratrol" Household Flea Spray for 90 day control of adult fleas and larvae in homes, apartments and clinics:

- 1. Shake pouch for 20 seconds
- 2. Cut off corner to open pouch
- 3. Empty entire contents of pouch into "Duratrol" Household Flea Spray pump-up sprayer.
- 4. Fill sprayer with tap water to the 1 litre level.
- 5. Screw on cap firmly (do not overtighten or it may crack).
- 6. Pressurize sprayer by pumping.
- 7. Shake well before use.
- 8. Follow label instructions for application to household surfaces.

DO NOT USE AS SPACE SPRAY.

THOROUGHLY vacuum all carpeting, upholstered furniture, along baseboards, under furniture and in closets. Seal vacuum bag and dispose. Mop hard surface floors. Pet bedding should be washed or replaced with clean, fresh bedding prior to treatment. Adjust sprayer to deliver a fine wet spray to infested areas. Thoroughly treat all baseboard areas, cracks and crevices in hard surface floors, and as a spot treatment only to areas of carpeting and broadloom and pet resting quarters where fleas and/or ticks may be present. DO NOT TREAT PETS WITH THIS DO NOT USE ON BEDDING FOR PUPPIES AND KITTENS LESS THAN PRODUCT. Spray with a smooth back and forth motion to 12 WEEKS OLD. deposit product uniformly. It is not necessary to soak the treated surface, but an even treatment is desirable. Noticeable flea reductions will be observed within 24 hours.

To treat other household pests including ants, carpet beetles, centipedes, cockroaches, crickets, earwigs, millipedes, silverfish, sow bugs, spiders, and ticks, direct spray to those areas where pests are found.

NOTE: When spot treating carpets or other fabric we recommend testing a hidden area for staining prior to spraying.

APPLICATION RATES:

12.5 mL/1 sq.m.(1.2 sq yds) - Light to moderate infestations. 25 mL/1 sq.m.(1.2 sq yds) - Severe infestations.

PRECAUTIONS: Hazard to Humans and Domestic Animals. Avoid breathing spray mist. Avoid contact with skin and eyes. Wash hands after spraying and before eating. Do not spray directly on pets or humans. Keep children and pets out of treated areas until spray has dried. Avoid contamination of food and food utensils. Do not use in serving areas while food is exposed. Do not use in nurseries or rooms where infants, ill or aged persons are confined.

Remove birds from areas being sprayed until completed. Cover fish aquariums and turn off filter while spraying. Use with caution around house plants.

This product is toxic to fish and birds. Keep out of any body of water. Do not contaminate lakes or streams by cleaning of equipment or disposal of wastes.

FIRST AID:

IF SWALLOWED: Call physician or Poison Control Centre. Drink 1 or 2 glasses of water and induce vomiting by touching finger to back of throat. Never give anything by mouth to an unconscious person. IF ON SKIN: wash skin with soap and water. IF IN EYES: flush eyes with plenty of water. If irritation persists, call a physician.

TOXICOLOGICAL INFORMATION: Chlorpyrifos is a cholinesterase inhibitor, treat symptomatically. Atropine only by injection is an antidote.

STORAGE AND DISPOSAL: Store in original container out of the reach of children. Do not freeze or store above 48 deg C (120 deg F).

Do not contaminate water, food or feed by storage or disposal. Wrap empty container in newspaper and dispose in household garbage.
