# FOR WILD MUSTARD CONTROL IN RAPE

BENAZOLIN is a selective herbicide for postemergence control of wild mustard and suppression of certain other broadleaf weeds in Polish and Argentine rape. The use of BENAZOLIN at recommended rates after the rape as 3 to 5 true leaves will kill or suppress wild mustard so that it will not longer compete with the crop if the mustard is in the 2 to 4-leaf stage at the time of spraying. Weeds such as lamb's-quarters, stinkweed and smartweed are not controlled. Some suppression of Canada thistle may be anticipated.

#### **DIRECTIONS:**

Use single application when the rape plants have 3 to 5 true leaves. Apply BENAZOLIN at the rate of 1.5 to 2.1 L per hectare, depending on the degree of weed infestation and size of the weeds. Use the lower rate for light infestations of small weeds and the higher rate for very heavy infestations. Apply in 55-100 L of water per ha and spray to give good coverage of the weeds.

### CAUTIONS:

Do not spray rape with a sprayer which is contaminated with 2,4-D or MCPA. Use only on crops recommended on the label. Avoid spray drift to other crops, forage or pasture, or ornamental plants. Wash sprayer with clean water before using sprayer for other crops. This product may be toxic to fish. Do not rinse equipment in streams or ponds or contaminate any body of water with this material.
