DIRECTIONS FOR USE

COCKROACHES, ANTS, FLEAS AND SILVERFISH

FOR USE IN DWELLINGS: For control of ants, fleas, silverfish, resistant as well as non-resistant cockroaches, crickets, earwigs, carpet beetles and sowbugs, make spot applications directly to the infested area. Application should be made as a coarse spray to wet the surfaces, or with a paint brush to the cracks and crevices of baseboard areas, around pipes and other breeding areas; surfaces behind and beneath cabinets, refrigerators, sinks and stoves and similar areas should also be treated. Treatments should be repeated monthly if required.

FOR USE IN MEAT PACKING AND FOOD PROCESSING PLANTS: In meat packing and food processing plants, only spray when plant is not in operation. Remove all food before treatment, cover all food

processing surfaces. No exposed meat products, ingredients or packaging materials to be left in the room and cover food handling equipment. Any treated surface that may contact meat food product or other food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing.

PRECAUTIONS: Harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing spray mist. Avoid all personal contact even with treated surfaces. Wash hands thoroughly after using and before eating, drinking or smoking. Avoid contaminating of food-stuffs or surfaces they touch.

Keep out of reach of children. Do not apply to surfaces where children play. Remove or cover all food & utensils before treatment.

Do not apply on animals or plants. Provide free ventilation during application. Operators using this product frequently should wear protective clothing. Do not use or store near heat or open flame.

FIRST AID INSTRUCTIONS: This product contains petroleum distillate. If swallowed, do not induce vomiting, call Physician immediately. If patient unconscious give him air. If in the eyes flush with plenty of water and call Physician. In case of contact, immediately wash skin with plenty of soap and water.

TOXICOLOGICAL INFORMATION: Diazinon is a cholinesterase inhibitor. Atropine is antidotal and may be administered using 1-2 mg every 15-30 minutes if necessary.

NOTICE TO USER: This control product to be used only in accordance with the directions on this label. It is an offence under the Pest Control Products Act to use a control product under unsafe conditions.
