#### USE:

For control of bacterial and/or fungal slime in pulp and paper mills.

## FEEDING:

CHIMTOX 230 may be drip fed continuously from the drum or fed by suitable chemical pumps such as adjustable proportioning, variable speed, positive displacement or reciprocating types. This product should be fed as early as possible in the system at such points including the hydropulper, machine chest or broke system.

## SYSTEM:

Severely fouled systems should be cleaned prior to treatment. Feed ahead of contaminated area.

Dosage will vary from 0.05 to 0.5 kg (0.042 to 0.42 litres) of CHIMTOX 230 per tonne of finished paper, depending on the type of stock, complexity of the system, quality of raw water and type and degree of contamination.
