For use as a spot, crack and crevice treatment to control crawling insects listed on front panel.

INDOOR USE: Thoroughly treat cracks, crevices, baseboards, underneath furniture and equipment, around garbage containers and other places where insects habituate.

OUTDOOR USE: Spray outside surfaces of screens, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter.

DIRECTIONS: Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will flow into cracks and crevices for insect control. If reinfestation occurs, repeat applications. Provide adequate ventilation after indoor use.

KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stove or other sources of heat, or store at temperatures over 50°C. Do not spray near open flame or spark. Do not puncture or incinerate. Harmful if swallowed, inhaled or absorbed through skin or clothing. Avoid contact with eyes, skin or clothing. DO NOT USE ON HUMANS, PLANTS, ANIMALS, FOOD STUFF, FOOD UTENSILS, FISHBOWLS, OR ANIMAL FEED AREAS. DO NOT USE AS A SPACE SPRAY. DO NOT CONTAMINATE FOODSTUFFS. In homes or dwellings, remove or cover all exposed food and cooking utensils before spraying. Thoroughly wash all surfaces that might contact food before reuse.

In meat and food processing plants and food service establishments, treat only when plant is NOT in operation. Remove or cover all food packaging materials, and utensils and cover all food processing surfaces before spraying. After treatment, wash all surfaces that may contact food and rinse thoroughly with potable water before resuming operations. Do not use in rooms where milk is processed, handled or stored.

FIRST AID TREATMENT: Contains volatile petroleum distillate.

If swallowed, do not induce vomiting. Call physician immediately. Chlorpyrifos is a cholinesterase inhibitor. Atropine is antidotal. In case of contact with the skin, wash with soap and water. If in eyes, flush with water 15 minutes, get medical attention.

DISPOSAL: When container is empty, press button to release all pressure. Dispose of empty container in accordance with provincial requirements. For information on the disposal of unused, unwanted product and the clean up of spills, contact the regional office of Environmental Protection, Environment Canada.
