DIRECTIONS:

SHAKE CAN WELL BEFORE USING. Hold can about 2 cm above pet's back and spray the foam from the pet's head to tail. Do not spray face, eyes or genitals. Rub the foam thoroughly into the

pet's coat using an amount which moistens, but does not soak the entire haircoat. Do not use on nursing puppies or kittens under 8 weeks of age, or nursing females. Do not treat pets more than once a week. Do not use on sick animals. Do not use on animals under drug or other pesticide treatment. Consult veterinarian before using on pregnant animals. For effective flea & tick control, treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves, or other sources of heat or store at temperatures over 50'C. Do not spray in eyes, or face, or on genitals of pet. Discontinue use if dermal or nasal irritation develops. Do not use near fish, food or foodstuffs. Avoid inhalation of spray. Avoid skin contact by wearing rubber gloves. Wash hands after use.

DISPOSAL: When container is empty press valve to release pressure. Dispose of empty container in regular household garbage. Do not puncture or incinerate.
