For use as a spot or crack and crevice treatment to control insects listed on front panel.

GENERAL DIRECTIONS: SHAKE CAN WELL BEFORE USING.

Test a small inconspicuous area of the carpet for color fastness & staining before full application. Hold container approximately 30 cm from surface being sprayed and spray until wet. Thorough applications produce a coating which will vapourize into cracks and crevices for insect control. If reinfestation occurs, repeat applications as necessary. Cover fish bowls and remove pets for one hour when spraying. Provide adequate ventilation after indoor use. KEEP PETS AND CHILDREN AWAY FROM SURFACE UNTIL DRY.

INDOOR USE: Thoroughly treated cracks, crevices and spots along and behind baseboards, underneath furniture and equipment around garbage containers, localized areas of floors and floor coverings and other places where insects hide or are seen.

OUTDOOR USE: Spray spots on outside surfaces of screen frames, doors, window frames, foundations, patios, light fixtures and other places where insects may alight, or congregate and enter. The cluster flies and house flies will be killed when they land on the treated surfaces.
