DIRECTIONS

Shake can before using. Remove cap. Hold can upright. Point valve opening away from face. With wind at back, aim at nests in trees, bushes, under eaves, chimneys, cracks or crevices, etc. Thoroughly saturate nest with spray, contacting as many insects as possible. To prevent insects from falling on skin and clothes, do not stand directly under nests. Best result can be obtained if nest is sprayed in the late evening when most insects are at rest. If-reinfestation occurs, repeat treatment.

Avoid inhalation of spray fumes. Do not spray in areas where food and feed stuffs are exposed or handled. Do not use as space spray. Avoid contact with skin. Wash hands after use.

CAUTION

KEEP OUT OF REACH OF CHILDREN. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures above 50 °C.
