**USE AND STORAGE DIRECTIONS FOR THE QUICK CONNECT SPRAYER:**

1. Pull trigger sprayer from bottle.
2. Pull colour hose connector and coil from trigger sprayer handle.
3. Insert hose connector into colour spout on cap until it "clicks" in place.
4. Flip up spout.
5. Turn sprayer nozzle to open, and spray.
6. Adjust spray by turning nozzle to give a coarse spray.
7. Storage: After use, flip spout down to the "flat" position to close. No need to disconnect trigger sprayer. Close nozzle on trigger sprayer. Snap trigger sprayer back into place.

**APPLICATION:** Hold container upright and apply as a coarse spray to infested surfaces until wet. Do not use as a space spray. Do not spray on pets, humans or plants. Avoid excessive wetting of asphalt, tile, rubber and plastic materials. Remove or cover all food and utensils before treatment.

**AREAS TO TREAT:** Sinks and drainpipes, workshops and basement areas, storage closets, behind appliances, around house foundations, garbage can areas, patio areas, window frames and doorways.

**DIRECTIONS FOR USE:**

PEST	TIMING APPLICATION
Cockroaches, ants, silverfish, spiders, crickets, earwigs, sowbugs, millipedes, centipedes	Apply spray to localized areas until wet. Spray areas where these pests are found or may hide including cracks and crevices, behind and beneath cabinets, refrigerators, sinks, stoves, garbage cans, baseboards, plumbing and other utility installations. Treat ant trails, nests and points of entry such as around windows, door frames and sills. Repeat treatment if pests re-appear.

Carpet beetles	Spray edges of carpeting, under carpeting and rugs. Make spot treatments to floor and baseboards. Repeat if pests re-appear.
Clusterflies, clover mites	Spray outside and inside surfaces of window frames and cracks and crevices where flies can enter in the fall and spot-treat indoors when flies first appear. Repeat if pests re-appear.
Brown dog ticks and fleas	Spot-spray infested areas around baseboards, windows and door frames, wall cracks, sleeping areas of pets. Repeat as necessary. Place fresh bedding in animal quarters after treatment. <b>DO NOT APPLY TO FURNITURE. DO NOT TREAT PETS WITH THIS PRODUCT.</b> For effective flea and tick control, pets should be treated with a registered flea and tick control product designed for use on pets (N.B. this product is not for use on pets), and treatment of the pet must be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas prior to treatment with this product.
Flies, mosquitoes, wasps (outdoors)	Apply as an aid in reducing annoyance from these insects. Spray outside surfaces of screens and doors, or wherever these pests may enter the room. <b>DO NOT USE AS A SPACE SPRAY.</b>

**PRECAUTIONS:**

KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Avoid contact with skin and eyes and inhalation of vapours or spray mist. Avoid contamination of food and feed. Wash thoroughly after using. Do not allow others such as children and pets on treatment area during application or to re-enter treated areas until spray has dried. Remove or cover all food and utensils before treatment.

**FIRST AID:**

In case of poisoning, obtain medical attention immediately taking the pesticide container with you or contact a Poison Control Centre. If swallowed, give one to two glasses of water and induce vomiting.

Repeat with water until vomit is clear. Do not cause vomiting if the patient is unconscious or in a convulsive state. If in eyes, flush with plenty of clear water for 5-10 minutes and obtain medical attention. If on skin, remove contaminated clothing and wash skin thoroughly with soap and water. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:**

Diazinon is a cholinesterase inhibitor. Atropine is antidotal.

**DISPOSAL INSTRUCTIONS:**

DO NOT RE-USE CONTAINER. Wrap and dispose of empty container in household garbage.
