DIRECTIONS: The product can be used undiluted or diluted. When dilution is required, dilute concentrate with a light mineral oil or an odourless light petroleum hydrocarbon at the rate of one part concentrate to two parts oil and mix well.

CONTACT SPRAY: Use undiluted to kill cockroaches, silverfish, earwigs, ants, spiders and beetles in sheltered situations. Use equipment such as ULV, to deliver a fine mist (droplets of 30 microns in diameter or less). Apply spray into cracks and crevices and hiding places such as baseboards moist areas, openings around sinks, drains and pipes, behind cabinets and storage areas. Spray and trails and around door sills, window frames, or in ant nests. Insects must be contacted to be killed. Use dosage rate of approximately 50 mL per 100 sq. m if room surface. Leave room closed for 20-30 minutes. Do not remain in treated areas. Do not allow spray to contact stored food.

SPACE SPRAY:

- 1. Use undiluted to kill: Indian Meal moth, Confused flower Beetle, Saw-toothed Grain Beetle and Cockroaches that infest dried fruit products in storage.
- 2. Use undiluted to kill: Rice Weevil, Yellow Meal Worm, Cadelle, Confused Flour Beetle, Saw-toothed Grain Beetle, Angoumais Grain Moth, Mediterranean Flour Moth and Indian Meal Moth of stored food)stored in multi-wallpaper bags or in cloth bags) in warehouses, storage rooms and similar location.
- 3. Use diluted (see directions for dilution) to kill flying and crawling insects in meat processing establishments.

Close room or warehouse and shut off ventilation system. Using a spraying device or ULV, to deliver a fine mist (droplets 30 microns in diameter or less), apply DISVAP 3-6- 10:

- a) undiluted, at a rate of 200 mL of spray per 100 cu. m of room space for case 1
- b) undiluted, at a rate of 100 mL of spray per 100 cu. m of room space for case 2
- c) diluted, at a rate of 100 mL of spray per 100 cu. m of room space for case 3.

Direct mist upwards to all parts of the room especially windows and other light sources. Repeat monthly if necessary. Wherever possible keep doors and windows closed for 30 minutes after treatment. Also direct mist into areas where insects are present. Do not remain in treated areas. Spray only when temperature is under 32°C .

Ensure proper ventilation after sealed areas have been treated. Following ventilation, clean up dead insects.

4. Use diluted (see directions for dilution) to kill flies, mosquitoes, and gnats in open areas. Use at a time when temperature is cool (24°C or less) and the wind velocity is approximately 8 km/hour. Using an equipment such as ULV, to deliver a fine mist (droplets of 30 microns in diameter or less), spray DISVAP 3-6-10 at the rate of 400 mL/minute upwind of the area to be controlled. If the equipment is truck mounted, keep the speed at approximately 8 km/hour. Repeat application as required.

PRECAUTIONS: Flammable mixture. Product contains Petroleum Distillate. Do not store, pour or use near fire or flame. Wear mask or respirator when applying spray mist. Wear protective clothing. Harmful if swallowed, inhaled, or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, water or food stuffs. In food processing plants and food service establishments, apply only when plant is NOT in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operations. Do not use in milk processing plants or milk parlours. KEEP OUT OF REACH OF CHILDREN. Do not use near birds, fish or pets.

Do not spray on plastic or varnished surfaces. Do not spray closer than 1 m to fabric. Do not re-use empty drum. Destroy by perforating or crushing and burying in a non-crop, non- graze area away from water supplies.
