Light.....1/60 - 15 mL per litre of water
Normal.....1/40 - 25 mL per litre of water
Heavy.....1/25 - 50 mL per litre of water

At a 1 to 20 dilution (50 mL/litre water) QUATO is a germicide and disinfectant against: *Staphylococcus aureus*, *Salmonella typhosa*, *Trichophyton interdigitale*, *Salmonella choleraesuis*, *Escherichia coli*, and *Pseudomonas aeruginosa*.

At a 1 to 60 dilution (15 mL/litre water) QUATO is a very good sanitizer-deodorizer because it destroys odour-producing bacteria.
