DIRECTIONS FOR USE:

FOR DARKLING AND LESSER MEALWORM BEETLE CONTROL (Adults and Larvae) IN  
POULTRY GROW OUT HOUSES.

For Dirt Floored Grow Out Houses: Apply SafeCide IC dry with a

fertilizer or seed spreader directly to soil at the rate of 50-100 grams/square meter when house is empty and after litter has been removed. Wear a dust mask or respirator when applying. For layer Houses and Cement Floored Grow Out Houses: Mix SafeCide IC at the rate of 40-80 grams/litre of water. Using appropriate pressure spray equipment, saturate side walls, top plates, posts and framing. Spray mix into cracks and crevices around insulation. Apply at the rate of 1 litter of mix per square meter of treated surface when house is empty. If facility is washed down and sanitized using standard cleaning and disinfecting procedures, SafeCide IC must be reapplied to continue beetle control.

#### PRECAUTIONS:
