DIRECTIONS FOR USE

CATS AND DOGS: Cover pet's eyes with hand and with a firm, fast stroke to get a proper spray mist, spray head, ears and chest until damp. With fingertips, rub onto face and around mouth, nose and eyes. Then spray neck, middle and hindquarters, finishing legs last. For best penetration of spray to the skin, direct spray against the natural lay of the hair. On longhaired dogs, rub your hand against the lay of the hair, spraying the ruffled hair directly behind the hand. Make sure that the spray thoroughly wets ticks. Repeat treatment as needed; do not treat more often than once per week. For improved appearance, wipe off excess with towel and comb or brush pet. Repeat grooming when dry.

PET'S SLEEPING QUARTERS: Spray around baseboards, windows, door frames, wall cracks and local area of floors. Repeat as needed. Pet's bedding should be sprayed, making sure the area beneath the bedding is sprayed too. After spray has dried, remove old bedding and replace with fresh bedding.

PRECAUTIONS

HUMAN: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed or inhaled. Avoid breathing mist. Avoid contamination of food. Wash hands with soap and water after using.
