For open areas, place carpets at night, on weekends or anytime area is not in use. In food processing plants, use only when the plant is not in operation. Do not place carpet on surfaces that are used for food preparation. Open areas should be vacated prior to use. Carpets should be placed out for at least 4 hours for maximum control of cockroaches.
