FOR MANUFACTURING/FORMULATING PURPOSES ONLY

D-TRANS Intermediate 2247 is to be used at 6.00% with 4.00% isopropyl alcohol and 90.00% deionized water to produce a liquid insecticidal spray.

PRECAUTIONS:

Harmful if swallowed, inhaled or absorbed through the skin. Irritating to eyes. Wear eye protection while mixing or handling. Wash thoroughly after handling. Wash contaminated clothing before reuse. Flush contaminated eyes with plenty of water and get prompt medical attention. Avoid breathing vapors and spray mist. Do not contaminate food or feed.

This product is toxic to fish, other aquatic animals and birds. Keep out of lakes, ponds, or streams. Do not contaminate water by cleaning of equipment or disposal of wastes.

FIRST AID:
