DIRECTIONS FOR USE: To be used only in the manufacture of an insecticide which is registered under the Pest Control Products Act.

TOXICOLOGICAL INFORMATION: Compound inhibits cholinesterase resulting in stimulation of the central nervous system, the parasympathetic nervous system, and the somatic motor nerves. Administer atropine sulfate in large therapeutic doses. Repeat as necessary to the point of tolerance. 2-PAM is also antidotal and may be administered in conjunction with atropine

Do not give morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning, even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically. STORAGE: Do not store below 7EC. Keep in original container during storage. Store product in cool, dry, well-ventilated place away from seed, feed, fertilizer or other pesticides.

Keep away from fire, open flame or other sources of heat.

DISPOSAL: Canadian formulators using this product should dispose of unwanted active ingredient and containers in accordance with municipal or provincial regulations.
