DIRECTIONS FOR USE

Thoroughly clean brushes, combs, rollers, manicure and other salon tools prior to complete immersion for 10 minutes (or as required by local authorities). Mix 30 mL of BARBICIDE in one litre water. This makes 1536 ppm active product. For a Pseudomonacidal Disinfectant, mix 60 mL BARBICIDE in 1 litre of water (3072 ppm active product). Fresh solution should be prepared daily or more often if solution becomes dirty or diluted. Rinse with water after immersion to remove BARBICIDE.

PERFORMANCE: When tested with full immersion for 10 minutes in a solution created as above BARBICIDE has been found to be effective as a disinfectant, as a fungicide (against Trichophyton mentagrophytes), as a pseudomonacide (against Pseudomonas aeruginosa), and as a virucide (against Herpes simplex types 1 and 2).

GENERAL USE: Wipe telephones, door knobs, lavatory fixtures, chair arms and counter tops with a solution of 30 mL BARBICIDE diluted in 1 litre water. Surface should remain wet for 10 minutes.

PRECAUTION: Harmful if swallowed. Avoid getting in the eyes or on the skin. Do not mix with soaps or synthetic detergents. When the container is empty, rinse with water and discard.

FIRST AID: If swallowed, promptly drink a large quantity of water; avoid alcohol. Call a physician or poison control centre immediately. In case of contact with skin or eyes, immediately wash with water. If in eyes, call a physician. If skin irritation persists, get medical attention.
