It may be necessary to repeat treatment within 1 to 2 weeks if reinfestation occurs.

DIRECTIONS: FOR SPOT TREATMENT ONLY. Shake well before using. Hold bottle in upright position 25-30 cm away from surface being treated. Test small area of carpet for color fastness before full application. Spray surface until thoroughly wet. Spot treat in areas where pests are most likely to be present. Repeat application of reinfestation occurs. Treat your pet with HAGEN flea and tick products registered for use on pets before allowing them into the treated areas.

DO NOT TREAT PETS WITH THIS PRODUCT. For effective flea and tick control, pets should be treated with a registered flea and tick control product designed for use on pets, and treatment of the pet should be combined with the sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas prior to treatment with this product.

THIS PRODUCT IS NOT TO BE USED DIRECTLY ON PETS. KEEP PETS AND CHILDREN AWAY FROM TREATED AREAS UNTIL ALL SURFACES ARE DRY.
