DIRECTIONS FOR USE:

To be used only in the manufacture of a pesticide which is registered under the PEST CONTROL PRODUCTS ACT.

PRECAUTIONS:

PHYSICAL AND CHEMICAL HAZARDS:

Do not use or store near heat or open flame. FMB 451-8 Concentrated Liquid Germicide is a cationic germicide. Do not mix with soap or anionic materials.

STORAGE:

This product must be kept under locked storage sufficient to make it inaccessible to children or persons unfamiliar with its proper use. Do not contaminate water, food, or feed by storage or disposal. Open dumping is prohibited

DISPOSAL:

1. Rinse the emptied container thoroughly and add the rinsings to the treatment site.

2. Follow provincial instructions for any required additional cleaning of the container prior to disposal.

3. Make the empty container unsuitable for further use.

4. Dispose of the container in accordance with provincial requirements.

5. For information on the disposal of unused, unwanted product and the cleanup of spills, contact the Provincial Regulatory Agency or the Manufacturer.
