C-I-L Weed and Grass Killer is a fast acting, rain-fast herbicide which controls weeds and grasses around trees and shrubs, between plants and on driveways, patios and along fence lines. DO NOT USE ON DESIRABLE LAWNS. C-I-L Weed and Grass Killer becomes inactivated on contact with soil. It cannot spread to untreated areas and is harmless to tree roots, seeds and mature brown bark. Remove dead vegetation before replanting.

NOTE: The spray must not contact green bark, other desirable green growth or foliage, as serious injury to the plant may result.

HOW TO APPLY: Use watering can with fine spray or low pressure (large droplets) sprayer: Dissolve the contents of one packet (57g) in 10 litres of clean water, shake it at least one minute and apply to 20 m². If weed growth is extremely dense apply to 10m².

NOTE: Since soil inactivates the spray, use of muddy water or spraying of very dusty weeds will reduce effectiveness. Thoroughly wet all unwanted grass and weeds, all green parts of plants treated will be killed. Apply anytime during growing season but control is best when grasses and weeds are young. Control of perennial weeds will require repeat treatments.
