DIRECTIONS FOR USE:

Oilfield Applications:

Use 100 ppm active ingredient based on water content of system
until control is achieved. Maintenance dosage 10 - 25 ppm. In
all applications, cut or open the bag to expel the product into
the system in the areas specified below.

IN ALL CASES AVOID SKIN CONTACT.
WEAR PROTECTIVE GLOVES.

Gas Wells:

Introduce through wellhead valving system, so product drops down tubing.

Oil Wells:

Drop down tubing when sucker rods are pulled.

Storage Tanks:

Drop through thief hatch.

Cooling Towers:

Pre-clean heavily fouled systems. Shock dosages of 100 ppm based on the water content of the system may be used until control is achieved. Maintenance dosage 15 - 50 ppm. Cut or open the bag to expel the product directly into the sump of the system at a convenient point. Each stick contains 100 grams of active ingredient.

FIRST AID:

In case of contact with skin or eyes give prolonged irrigation with water. In case of ingestion wash out the mouth thoroughly with water and give water to drink. In all cases obtain medical attention.

NOTICE TO USER:

This product is to be used in accordance with the directions on this label. It is an offence under the Pest Control Products Act to use a control product under unsafe conditions.

PRECAUTIONARY STATEMENTS
