DIRECTIONS FOR USE:

General Use Directions for Disinfecting:

For use on hard non-porous surfaces such as floors, walls, metal surfaces, stainless steel surfaces, porcelain, and plastic surfaces. Remove gross filth and heavy soil deposits then thoroughly wet surfaces. Use 4 mL per litre of water for a minimum contact time of 10 minutes in a single application. Can be applied with a mop, sponge, cloth, coarse spray or by soaking. The recommended use solution is prepared fresh for each use then discarded. Rinsing is not necessary unless floors are to be waxed or polished.

Mildewstatic Instructions:

Will effectively control the growth of mold and mildew plus the odours caused by them when applied to hard, non-porous surfaces such as walls, floors and table tops. Apply solution of 4 mL per litre of water with cloth, mop, sponge or coarse spray making sure to wet all surfaces completely. Let air dry. Repeat application weekly or when growth reappears.

POULTRY HOUSE DISINFECTANT:

- 1. Remove all poultry and feed from premises, trucks, coops and crates.
- 2. Remove all litter and droppings from floors, walls, and surfaces of facilities occupied or traversed by poultry.
- 3. Empty all troughs, racks, and other feeding and watering appliances.
- 4. Thoroughly clean all surfaces with soap or detergent, and rinse with water.
- 5. Saturate all surfaces with the recommended disinfecting solution for a period of 10 minutes. (8 mL per litre of water)
- 6. Ventilate buildings, coops and other closed spaces. Do not house poultry or employ equipment until treatment has been absorbed, set, or dried.

7. Thoroughly scrub treated feed racks, troughs, automatic feeders, fountains, and waterers with soap or detergent, and rinse with potable water before reuse.

For use in federally inspected meat and poultry plants as a general cleaning agent on all surfaces or for use with steam or mechanical cleaning device in all departments. Before use of this compound, food products and packaging materials must be removed from the room or carefully protected. After use of this compound, all surfaces in the area must be thoroughly rinsed with potable water.

Use a ten (10 minute contact time for disinfection against all other bacteria, fungi, and viruses claimed.

Disposal of Infectious Materials: Blood/body fluids should be autoclaved and disposed of according to federal, provincial and local regulations for infectious waste disposal.

CLEANSING AND SANITIZING OF BODY SURFACES AND BODY ORIFICES OF HUMAN REMAINS:

To cleanse away skin secretions and accompanying malodour, to insure the removal of all soil and blood stains, and to remove and reduce surface contamination, apply 4 mL per litre of water

to the surface and body openings, natural or artificial. Allow a 10 minute contact time for optimal results. Bathe the entire body, using a sponge or washcloth. A soft handbrush may be employed on surfaces other than the face. Prepare a fresh solution for application of each remains.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Warning causes eye and skin irritations. Do not get on skin, in eyes or on clothing. Harmful if swallowed.

FIRST AID:

In case of contact, immediately flush eyes or skin with plenty of water for at least 15 minutes. For eyes, call a physician.
