### DIRECTIONS:

LIVESTOCK SPRAY: To control stable flies, house flies, horse flies, mosquitoes and gnats: apply 30 -60 mL per adult animal to wet the hair thoroughly with particular attention to legs, flanks, back, trunk and other body areas commonly attacked by these flies. Repeat weekly or as needed. To control face flies, horn flies, horse flies on beef cattle, dairy cattle (lactating or not) hogs, horses. Apply to the face of the animal in the

morning before releasing to pasture. Apply sufficiently to wet the face, but no more than 30 to 45 mL per animal. Repeat daily as needed. To kill fleas on horses, cattle and goats, and to protect against reinfestation, wet the animal by spraying. Repeat as necessary.

DO NOT spray in animal's eyes or mouth. Treat dairy cattle at least 20 minutes before milking. DO NOT spray directly on udders. Wash udders before milking. DO NOT cover horses after treating.

SPACE SPRAY: In hog, dairy and beef barns, milking parlours, milk rooms, dairies and poultry houses. To control house flies, stable flies, mosquitoes and gnats. Apply as a fog or fine mist, directing spray towards the ceiling and upper corners until the area is filled with mist, using about 60 mL per 30 m3 of space. For best results, close doors and windows before spraying, and keep them closed for 10 to 15 minutes. Vacate the area and ventilate before reentry. Repeat application as necessary.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Not for use on humans. Harmful if swallowed. Avoid contact with skin, eyes and clothing, and avoid inhalation of spray. Wear mask or respirator while fogging. Keep container closed. Wash after use. Do not remain in treated areas. Ensure proper ventilation after sealed areas have been treated. Any treated surface that may contact food or feed products should be washed thoroughly with potable water after spraying and before use. Cover milk and milk utensils to prevent contamination from spray and dead insects. Do not use in areas where beekeeping equipment or supplies are stored. Product toxic to fish. Do not contaminate any body of water.

DISPOSAL: Rinse empty container thoroughly and add rinse water to fogging machine tank. Follow Provincial instructions for any required cleaning of container prior to disposal. Dispose of empty container in accordance with provincial requirements. For more information on the disposal of unused or unwanted products and the clean up of spills, contact the Provincial Regulatory Agency or the manufacturer.

FIRST AID: If in eyes or on skin, flush with clean water, if irritation persists, obtain medical attention. If accidentally swallowed, get prompt medical attention.
