DIRECTIONS FOR USE:

Prior to the use of OMNITROL 900-K in water cooling towers, systems should be cleaned to remove algae growth and microbiological slime and other deposits. OMNITROL 900-K must be fed continuously to obtain a system concentration of 800 - 1000 ppm of Omnitrol 900-K.

PRECAUTIONS:

Harmful if swallowed. Avoid breathing vapours. Avoid contact with skin, eyes or clothing. Wear goggles or face shield and rubber gloves when handling. This product is a potential skin sensitizer.

ENVIRONMENTAL HAZARDS:

This pesticide is toxic to fish. Do not discharge effluent containing this active ingredient into lakes, streams, ponds, estuaries, oceans, or public waters. Do not reuse empty containers.
