DIRECTIONS FOR USE

Application should be made as a coarse spray to baseboards, areas around water pipes, cracks, crevices, surfaces behind and beneath cabinets, refrigerators, sinks, stoves, and other localized areas infested with insects. Repeat as necessary to maintain control. DO NOT apply as a space spray. Remove or cover exposed food and cooking utensils before spraying. After treatment wash all surfaces that may contact food and rinse with potable water.

PRECAUTIONS

Applicator should wear mask, gloves, and protective clothing. May be harmful if swallowed, inhaled or absorbed through the skin. DO NOT contaminate any body of water. Toxic to wildlife. KEEP OUT OF THE REACH OF CHILDREN. Store tightly closed in original container. Wash after handling or use. Keep product away from any source of heat. DO NOT use on pets or plants.
