DIRECTIONS FOR USE:

"Bumps" appear on the back of cattle in late December, January, February and March, depending on climatic conditions. These "bumps" are the grubs of heel flies which have already lived inside the animal for several months.

Begin treatment five to six weeks after the first "bumps" are noticed; examine animals periodically starting in December. Repeat the treatment four weeks after the first application. A third application is recommended where possible.

HAND TREATMENT: Mix at the rate of 500 grams of WARBLE FLY WASH in 10 L of water. Use a stiff brush and scrub the insecticide into hair of animal paying special attention to the "bumps." Use approximately 600 mL of the

mixture per animal.

POWER TREATMENT: Mix at the rate of 2.4 kg of WARBLE FLY WASH in 100 L of water. Wet the animal thoroughly, using a pressure of 2800 kpa with a nozzle containing a no. 5 disc. Hold the nozzle 30-40 cm away from the animal and apply the spray at an angle of approximately 60 degrees. For small herds, scrub the insecticide into the hair with a stiff brush.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN and SWINE. Do not store with food or feedstuffs. Keep the product dry. Toxic to fish. Store in a cool dry place.

FIRST AID: If on skin wash thoroughly.

TOXICOLOGICAL INFORMATION: May cause irritation to skin, eyes and respiratory tract. Wettable sulphur is used as a carrier.
