DIRECTIONS FOR USE:

NO-DAMP FUNGICIDE is recommended to control DAMPING-OFF diseases in seedlings and cuttings. NO-DAMP FUNGICIDE may be used safely on all plants. Water the diseased plants with the diluted solution. For preventative control, water the propagating soil before seeding or placing cuttings.

NO-DAMP FUNGICIDE may be used at double strength for severe cases. Keep well stoppered. Do not store in metal container.

Dilute NO-DAMP FUNGICIDE as follows: 10 mL in 1 L of water (2 teaspoons/quart), 50 mL in 5 L of water.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN AND DOMESTIC ANIMALS. Harmful if swallowed or inhaled. Discontinue use if skin or nasal irritations develop. Do not use near ignition sources.
