DIRECTIONS: Shake well. Repels mosquitoes for 3 hours. Also repels black flies, biting midges, deer flies, stable flies, ticks and chiggers. Apply sparingly not under clothing and only when necessary. Reapply after 3 hours if necessary. Spray foam into palms and spread evenly on exposed skin of legs and arms. **TO APPLY TO FACE:** Spray hands and apply avoiding eyes and mouth. Do not spray in enclosed spaces.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not place in hot water or near radiators, stoves or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50°C. Do not contaminate food, utensils or any body of water. Supervise applications on children. Do not use on infants under 6 months of age. In 6 month to 2 year olds, do not apply more than once a day. Not for daily use. Avoid application to hands. In 2-12 year olds, do not apply more than 3 times per day. Avoid contact with eyes and mouth, plastics and fabrics such as acetate, rayon and dynel. May damage furniture finish, plastics and painted surfaces.

FIRST AID: **If sprayed in eyes:** Remove contact lenses, and flush with water for 15 minutes. If irritation or other adverse effects develop wash with soap and water IMMEDIATELY. Seek medical attention if symptoms persist. **If accidentally swallowed,** contact Physician or Poison Control Centre IMMEDIATELY. **If inhaled:** Give artificial respiration if indicated. Seek medical attention. Always take container label with you when seeking medical attention.

TOXICOLOGICAL INFORMATION: Treat symptomatically.

DISPOSAL: When container is empty, press button to release all pressure then dispose in household garbage.
