DIRECTIONS FOR USE

Apply sufficient SANIBROM 40 BIOCIDE and an oxidant such as chlorine, sodium hypochlorite, or trichloro-s-triazinetrione to achieve a residual bromine level as needed to maintain control. A 0.5 to 2.0 mole ratio of sodium bromide to oxidant is recommended. Based on 1:1 mole ratio, 0.36 kg chlorine gas is recommended per litre of SANIBROM 40 BIOCIDE.
