HOW TO USE: SUPER-K Insect Spray is ready to use undiluted as it comes from the bottle and may be applied with either power-operated or hand sprayers. Apply as a coarse spray to infested surfaces until wet, moving the spray stream rapidly enough to prevent excessive wetting of surfaces and waste of material. Direct spray away from people, plants, and pets.

INDOOR USE: ANTS, COCKROACHES, (WATERBUGS), CRICKETS, SILVERFISH, SPIDERS, SAW-TOOTHED GRAIN BEETLES(EXPOSED STAGE). Spray in cracks, crevices, around baseboards and other places where these insects hide. Apply behind and beneath cabinets, refrigerators, sinks, stoves and in around waste containers. For ants, spray trails and places where ants enter premises. Repeat as needed. Do not spray foodstuffs or houseplants. Remove pets and cover fishbowls before spraying. Do not allow children to contact treated areas until surfaces are thoroughly dry.

BROWN DOG TICKS: Spray sleeping quarters of pets, around baseboards, window and door frames, wall cracks, and local areas of floors. Repeat as needed. Fresh bedding should be placed in animal quarters after spraying. Do not spray animals.

OUTDOOR USE: ANTS, CLOVER MITES, CRICKETS, EARWIGS, FLEAS, FLIES, GNATS, HORNETS, MILLIPEDES, MOSQUITOES, SOWBUGS, BROWN DOG TICKS AND WASPS: Spray infested areas thoroughly including outside surfaces of screens, doors, window frames, foundations, patios, or other places where insects may enter. For ants, spray hills and runways. For control of wasps and hornets, spray nests at night. Repeat as necessary. Do not spray vegetation.

PRECAUTIONS: Do not apply to rugs, carpets, draperies, wallpaper, or similar materials that may be stained. Avoid excessive wetting of plastics, rubber and asphalt material such as tiles and floor coverings. Do not use as a space spray.

Remove pets and cover fishbowls before spraying. Do not treat animals, humans, plants, or food utensils. Provide adequate ventilation of area being treated.

CAUTION: May be harmful if swallowed, inhaled or absorbed through the skin. Avoid breathing of spray mist. Contact with skin soap and warm water after handling. Combustible. Do not spray near open flame. Do not smoke while using. Do not store near excessive heat. Do not contaminate feed or food. KEEP OUT OF REACH OF CHILDREN.

FIRST AID: Contains petroleum distillates. If swallowed, do not

induce vomiting. In case of poisoning call a physician immediately. If on skin remove contaminated clothing and wash skin immediately with soap and water. If eyes are contaminated, wash immediately with flowing water for at least 15 minutes.

TOXICOLOGY: The compound inhibits cholinesterase resulting in stimulation of the central nervous system. This results in a sense of "tightness" in the chest, sweating, contracted pupils, stomach pains, vomiting and diarrhea. The antidote is atropine sulfate administered in large therapeutic doses repeated as necessary to the point of tolerance. Do not give morphine. Watch for pulmonary edema, which may develop in serious cases of poisoning even after 12 hours. At first sign of pulmonary edema, the patient should be placed in an oxygen tent and treated symptomatically.
