DIRECTIONS: Shake can before using. Remove cap. Hold can upright. Point valve opening away from face. With wind at back, aim at entrance of holes or nests in trees, bushes, under eaves, chimney cracks, crevices, etc. Thoroughly saturate nest with spray, contacting as many insects as possible. To prevent insects from falling on skin and clothes, do not stand directly under nest. Best results can be obtained if nest is sprayed in late evening when most insects are at rest. If re-infestation occurs, repeat treatment.

PRECAUTION: KEEP OUT OF REACH OF CHILDREN. Do not contaminate water. Avoid inhalation of spray. Do not spray in areas where foods and foodstuffs are exposed or handled. Do not use as space spray. Avoid contact with skin. Wash hands after use.
