SHAKE WELL BEFORE USE AND OCCASIONALLY WHILE USING!

DIRECTIONS FOR USE:

1. For best results, before spraying bathe and shampoo the pet with a shampoo recommended by your veterinarian.
2. Rub off excess water with a towel. Your pet does not have to be thoroughly dried.
3. Adjust the nozzle on bottle of "Sectrol" Two-Way Pet Spray to deliver a coarse spray. Hold sprayer within a few inches of the haircoat. Apply "Sectrol" Two-Way Pet Spray so that your pet is moist - not soaked.
4. Start by spraying your pet's head (avoiding contact with the eyes and mouth) and work your way back to the hind quarters. Spray under the haircoat by backcombing against the direction of hair growth with your other hand.
5. Rough up the hair as needed to expose the skin to

insecticide. It is important to apply "Sectrol" Two-Way Pet Spray as evenly as possible over your pet's body because fleas will migrate to untreated areas (e.g. toes, foot pads, around the ears, etc.).

6. Applying this product at the level described above will provide rapid flea kill and at least 8 days residual activity.
7. Allow your pet to dry. Do not towel dry as this will remove many of the "Sectrol" Two-Way Pet Spray microcapsules. (These microcapsules provide the insecticide's time-release residual activity). A blow dryer works well to shorten the drying time.
8. If required, reapply "Sectrol" Two-Way Pet Spray weekly. In addition to treating your pet directly, control of fleas in your pet's environment is important if you wish to eliminate fleas from your home. Ask your veterinarian about "Sectrol" Premise Flea Spray (No. 1494) to help eliminate fleas from the carpeting, furniture and other pet activity areas. When used as directed, "Sectrol" Premise Flea Spray provides 30 day residual control of fleas in the home.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN.

Avoid contact with eyes. Avoid breathing spray mist. Keep container closed when not in use. Cover or remove fish bowls and aquaria. Wash hands after spraying and before eating or smoking.
