DIRECTIONS FOR USE

FRIGATE XL is an agricultural surfactant for use with ROUNDUP, WRANGLER and LAREDO herbicides.

PRINCIPAL USE FRIGATE XL may be tank-mixed with ROUNDUP, WRANGLER OR LAREDO for improved seasonal control of quackgrass (couchgrass) (Agropyron repens) when using spray volumes greater than 100 litres per hectare.

Refer to ROUNDUP, WRANGLER or LAREDO labels for precautionary statements and general product information.

APPLICATION AND TIMING For best control quackgrass should be actively growing with ample leaf area (3 to 4 leaf stage) to absorb the spray. Quackgrass (couchgrass) should be at least 20 cm tall and tillering and the rhizomes undisturbed by cultivation. Rainfall after spraying may wash off chemical and reduce effectiveness; dry conditions for six hours after treatment are essential.

Observe label recommendations for ROUNDUP, WRANGLER or LAREDO when using in conjunction with FRIGATE XL.

MIXING FRIGATE XL has been specially formulated for ease of mixing. Add ROUNDUP, WRANGLER or LAREDO to the required amount of water in the spray tank under agitation and then add the recommended quantity of FRIGATE XL and continue agitation. When water temperature is less than 5EC, premix FRIGATE XL with an equal volume of warm water (greater than 25EC) before adding to spray tank.

RATE OF USE Use 2.35 liters of ROUNDUP, WRANGLER or LAREDO in at least 100 liters of water per hectare in combination with 0.5% FRIGATE XL (0.5% liters per 100 liters of spray solution).
