DIRECTIONS FOR DISINFECTION AGAINST BACTERIAL RING ROT DISEASE OF  
POTATOES DISINFECTION OF POTATO STORAGE AREAS AND EQUIPMENT:

Prepare a solution by mixing 6 mL of HY-X in 1 litre (L) of water  
(600 mL of HY-X in 100 L of water). Thoroughly wash seed  
cutters, potato diggers, graders and other equipment, also walls  
and floors of storage areas with water. Then apply the HY-X  
solution by spraying or sponging. Dip seed-cutting knives  
regularly into the solution.

DISINFECTION OF USED POTATO BAGS: Soak the bags in the HY-X  
solution (600 mL HY-X in 100 L of water) for one hour. About 250  
bags can be disinfected in 200 L of solution. Renew solution  
when dirt accumulates. If the water is very hard, use rain water  
if at all possible.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid contamination  
of food or feed. Do not mix with soap or household detergents.
