DIRECTIONS FOR USE:

Paper Mills:

CHIMTOX 960 should be used at 0.07 - 0.12 kg per ton of dry paper and paperboard produced, at least once per day.

Oilfield Applications:

Use 100 ppm active ingredient based on the water content of the system until control is achieved. Maintenance dosage is 10-25 ppm. In all applications, cut or open the bag to expel the product into the system in areas specified below:

In all cases avoid skin contact, wear protective gloves.

Gas Wells:

Introduce through wellhead valving system, so product drops down tubing.

Oil Wells:

Drop down tubing when sucker rods are pulled.

Storage Tanks:

Drop through thief hatch.

Cooling Towers:

Pre-clean heavily fouled system (e.g. with chlorine). Shock dosages of 100 ppm based on the water content of the system until control is achieved. Maintenance dosages is 15-50 ppm. Cut or tear open the bag to expel the product directly into the sump of the system at a convenient point.

In all cases avoid skin contact, wear protective gloves.
