DIRECTIONS: Apply with a paint brush or as a coarse spray. Repeat as necessary to maintain control. Do not use in cupboards where food is stored. Do not apply to rugs, carpets, draperies, wallpaper or similar materials that may be stained. Solvent may stain or damage certain plastic, rubber and asphalt materials. Avoid excessive wetting. Do not use as a space spray. Food and utensils should be removed from area before spraying. Surfaces subject to direct contact with food should be thoroughly cleaned after spraying.

COCKROACHES, ANTS, CRICKETS, SILVERFISH, CARPET BEETLES AND EARWIGS: Thoroughly treat cracks, crevices, baseboards, spaces around water pipes and tanks. Surfaces behind and beneath cupboards, refrigerators, sinks, stoves, around garbage containers and other areas where insects dwell.

BROWN DOG TICKS AND FLEAS IN BUILDINGS: Clear area of bedding and debris before treating. Thoroughly spray infested areas around baseboards, window and door frames, wall cracks, localized areas of floors and floor coverings where pets normally rest or lie down. Thoroughly treat animal sleeping quarters. Do not spray on pets. Allow treated areas to dry thoroughly and replace with clean bedding before allowing use by animals. Repeat applications as infestations warrant.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Do not get into eyes. Avoid contact with the skin and clothing. Avoid inhalation of vapours or spray mist. Wash thoroughly after handling and before eating, drinking or smoking. Avoid contamination of food, utensils and feed. Flammable mixture: do not use or store near heat or open flame. Do not apply to plants, animals or humans. Remove pets and fishbowls before spraying and do not return them for at least 4 hours after treatment. Care should be taken to avoid insecticide deposits that children might contact.

FIRST AID: For external contact, wash with soap and water. If in eyes, flush with plenty of water and get medical attention. Contains petroleum distillate. If swallowed, do not induce vomiting. Call a physician or poison control centre immediately. Never give anything by mouth to an unconscious person.

TOXICOLOGICAL INFORMATION: Stomach lavage. Atropine is antidotal. Diazinon is a cholinesterase inhibitor. Antidote: atropine sulfate at 1-2 milligrams every 15 minutes may be necessary.

DISPOSAL: Do not re-use empty container. Wrap empty container and discard in household garbage.
