DIRECTIONS:

DEARCIDE 702 is recommended for the control of bacteria, algae and fungi in recirculating cooling water systems. For heavily

fouled systems and initial dosage of 300 to 900 ppm is recommended. When control is achieved, dosage levels may be reduced to 150 to 250 ppm.
