USE AND STORAGE DIRECTIONS FOR THE QUICK CONNECT SPRAYER:

- 1. Pull trigger sprayer from bottle.
- 2. Pull red hose connector and coil from trigger sprayer handle.
- 3. Insert hose connector into red spout on cap until it "clicks" in place.
- 4. Flip up spout.
- 5. Adjust spray nozzle to deliver a stream for cracks and crevices or a wide spray for other areas.
- 6. Aim sprayer nozzle at centre of weed and spray to wet.
- 7. Storage: After use, flip spout down to the "flat" position to close. No need to disconnect trigger sprayer. Close nozzle on trigger sprayer. Snap trigger sprayer back into place on bottle.

CONTROLS OVER 50 VARIETIES OF LAWN WEEDS

<u>CONTROLS</u>: Dandelion, Plantain, Chickweed, Clover, Bedstraw, Black Medick, English Daisy, Curled Dock, Heal-all, Ground Ivy (Creeping Charlie), Knotweed, Ragweed, Shepherd's-Purse, plus over 35 other broadleaf weeds.

DIRECTIONS:

Apply when weeds are actively growing. Do not water for 48 hours. Rain within 6 hours reduces effectiveness. Spray acts within a few days and weeds gradually die. Grass fills in as weeds disappear. Some weeds may require up to 4 weeks for complete kill. Repeat in 3-4 weeks if necessary. For numerous weeds, spray overall with KILLEX® LIQUID.

PRECAUTIONS:
