#### DIRECTIONS FOR USE

##### SHAKE WELL BEFORE USING

Spray infested surface until wet. In food processing plants and food service establishments, apply only when plant is not in operation. Remove all food before treatment. Cover all food processing surfaces and thoroughly clean with potable water before resuming operations. Do not use in serving areas while food is exposed.

COCKROACHES, ANTS, SPIDERS, SILVERFISH, CRICKETS:

Spray areas where these pests are found or may hide, including dark corners of rooms and closets, cracks, crevices, along baseboards, and door sills and frames, behind and beneath sinks, stoves, refrigerators, cabinets and around garbage cans, plumbing and other utility installations. Contact insects directly whenever and wherever possible. Treat Ant trails, nests and points of entry. Repeat treatment as necessary. CARPET BEETLES: Spray edges of carpeting and under carpeting and rugs. Make localized application to the floor and baseboards. Spray directly into cracks, crevices and infested areas of shelving. Repeat as necessary.

BROWN DOG TICKS: Thoroughly spray sleeping quarters of animals. Spray infested areas around baseboards, windows and door frames, wall coverings. Applications should be repeated as necessary. Fresh bedding should be placed in animal quarters following treatment. DO NOT TREAT ANIMALS WITH THIS FORMULATION.

FLIES, MOSQUITOES, WASPS AND SMALL FLYING MOTHS OUTDOORS: For outdoor use only as an aid in reducing annoyance from these insects. Spray outside surfaces of screens, doors, window frames or wherever these insects may enter the room. Also treat surfaces around the light fixtures on porches, in garages and other places where these insects alight or congregate.

FLIES, ANTS OUTDOORS: For treatment of localized infestations of these insects in outdoor areas, spray weeds and bushy non-crop areas around the home thoroughly. Avoid spraying desirable plants. For Ants, thoroughly wet hills and runways. Repeat applications as infestations warrant and as reinfestations occur.

DISPOSAL

Do not reuse empty container. Return to drum reconditioner or follow provincial instructions for any required cleaning of the container prior to its disposal. Make the empty container unsuitable for further use. Dispose of the container in accordance with provincial requirements.
