KEMMIST insecticide is designed for use in the Automatic dispensers and releases a metered dose of 55 mg of insecticide every 15 minutes. For the control of flies, mosquitoes, gnats, and drosophila in restaurants, food processing plants, meat processing plants, hospitals, dairies, horse stables, cow barns, poultry houses and other areas of at least 170 cu. m of free flow air space where these flying insects are an annoyance.

DIRECTIONS: Each dispenser is designed to protect an area up to

170 cu. m for up to 30 days. Remove protective cap from top of can and insert can into special automatic dispenser. Place dispenser 2-3 metres above floor at a point where air flow will carry insecticide throughout the area. Do not install directly over food or food packaging surfaces.

CAUTION: In meat packing plants, spray only when plant is not in operation. No exposed meat products, ingredients or packaging materials to be left in room. Cover food handling equipment. Any treated surface that may contact meat food products must be washed and rinsed thoroughly with potable water after spraying and before re-use for processing.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. CONTENTS UNDER PRESSURE. Do not expose to temperature above 50 'C. Do not spray neat open flame or spark. Do not puncture or incinerate. Remove bird cages and cover fish bowls while area is being treated. Do not use close to varnished, or polished plastic surfaces. Do not contaminate food, feed, or water troughs. Avoid contact with skin and inhalation of spray mist. Wash after using. Do not use in nurseries or rooms where infants, ill or aged persons are confined.
