SHAKE BEFORE USE
KEEP UPRIGHT WHILE SPRAYING

DIRECTIONS FOR USE: To kill Flies, Mosquitoes, Gnats, Wasps and Flying Moths: Close all windows and doors and direct spray upward into centre of room with a slow, sweeping motion. Spray 5 to 10 seconds for average room. Keep nozzle 1 metre from surfaces. Keep room closed for 15 minutes after spraying. To kill Cockroaches, Silverfish, Crickets and Ants: Spray baseboards, cracks, crevices, moist areas and openings around sinks and pipes and other hiding places, hitting the insects directly. Spray ant hills and ant trails over window and door sills and other locations. Repeat as necessary for control.

FOR OUTDOOR AND FLOWER GARDEN USE: For Caterpillars, Climbing Cutworms, Japanese Beetles, Aphids, Lace Bugs, Leaf Hoppers,

Thrips(exposed) and Spider Mites. For bugs on such plants as Asters, Azaleas, Begonias, Chrysanthemums, Dahlias, delphiniums, Gladioli, Irises, Marigolds, Petunias, Roses and Snapdragons. Also for bugs on evergreens and small ornamental deciduous trees, shrubs and vines. For best results, spray in evening or on a cloudy day when air is still. Use slow sweeping motion. Keep can 45 cm from plants. Avoid wetting foliage with the spray. Spray rows at the rate of 30 cm per second. For heavy growth, spray row on both sides. Repeat when needed. Spray with caution on young plants and new growth. Do not spray garden when temperature exceeds 32 degrees C.

PRECAUTION: Keep out of reach of children. Contents under pressure. Do not place in hot water or near radiators, stoves, or other sources of heat. Do not puncture or incinerate container or store at temperatures over 50 degrees C. May stain finished surfaces if sprayed too closely.

In meat packing plants, food processing plants and food service establishments, only spray when plant is not in operation. No exposed food or meat products, ingredients or packaging materials are to be left in the room. Cover food handling equipment. Any treated surface that may contact meat food products should be washed and rinsed thoroughly with potable water after spraying and before re-use for food processing.
