For established turf fairways, etc. apply 90 mL of National Chemsearch CHEMWEED-265 mixed with 10 litres of water per 100 square metres, or 8.5 litres mixed with 300-400 litres of water per hectare. For spot treatment mix at the above proportions and use sprinkling can or power sprayer. For larger areas a Boom sprayer is recommended. For maximum results the area should not be cut for 2-3 days before or after spraying. Do not sprinkle or water for 24 hours after application. Full visible effect requires about three weeks.
