DIRECTIONS:

Skeeter Bombs are designed so they will "pop", rupture, dissolve or disintegrate when thrown in water. Once action starts, the especially formulated solution can be seen "shooting" across the surface of the water in all directions. This surface action will continue until the surface is completely covered, thus lowering the surface tension of the water. Surface action then becomes increasingly slower, resulting in an unused amount of material.

In small pools, artificial containers, etc. only a few seconds are required for effective coverage. If the water is cool (20 deg C or lower) the initial discharge of the solution will require from 5 to 40 minutes. Each Skeeter Bomb should larvicide 10 square metres of open and unobstructed water surface with a depth of about 15 cm. Proportionately more capsules should be used for larger areas and greater depth. Allowance has been made for Skeeter Bombs retaining, at times, a portion of the solution. In many cases this is advantageous, since it provides for additional "continuing action".

Use of this product for larviciding in bodies of water is limited to water wholly contained within the property of the user, and where there is no outflow beyond the property limits.

PRECAUTIONS:

Keep Skeeter Bombs dry. Combustible mixture. Do not store under excessive conditions of heat or humidity, or in direct sunlight. Keep away from open flame. Do not store above room temperature. Avoid contamination of feed or foodstuffs. Keep out of reach of children. Do not ingest.
