DIRECTIONS: Kills flying insects in livestock housing areas including Dairy Barns, Beef Barns, Hog Barns, and Milk Houses. Remove all animals from treatment area before using as a space spray. Close all windows and doors and extinguish open flames during treatment. Apply at a rate of 15 seconds per 30 m3 of space. Direct mist upwards in sweeping motions towards all parts of the building, especially windows and other light sources and where insects are present. When treating small areas, you need only partially depress the valve. When treating large housing areas, you may depress the valve until it clicks, and then it will be locked in an open position allowing you to remove your finger. After you have completed spraying, stop the spray by pushing the valve arm up with your thumb. Keep room closed for

30 minutes and then ventilate treated areas thoroughly for at least 30 minutes before animal re-entry.
