**DIRECTIONS:**

For **Vegetable, Small Fruit, Flower and Ornamental gardens**. To control cutworms, sowbugs, earwigs and sap beetles, set out small quantities of pellets around newly planted vegetables and bedding plants. Treat seeded crops on emergence. Shake pellets from dispensing spout on side of container. Do not handle directly. Do not harvest garden vegetables for 14 days after last application when product is used in rows or around base of vegetables.

For **established small fruits and ornamentals** or for insect control **around buildings** set out small piles of pellets as bait stations, covering each pile with a board, shingle or

weighted foil plate. Covered bait stations attract sowbugs, earwigs and sap beetles, wood roaches and millipedes as well as provide protection to pets. Moisture from the soil or light sprinkling will cause the pellets to swell and activate the attractants. Baits are effective for up to 10 days.

**PRECAUTIONS:** KEEP OUT OF REACH OF CHILDREN AND PETS.

Hazardous if swallowed, inhaled or absorbed through the skin. Wash thoroughly after use. Do not contaminate feed, food, ponds or streams.

**FIRST AID:** **If in eyes,** flush with water for 15 minutes. **If on skin,** wash with soap and water. **If swallowed,** induce vomiting and get to physician or hospital. DO NOT TRY TO CAUSE VOMITING IF THE PATIENT IS UNCONSCIOUS OR IN A CONVULSIVE STATE. Take container, label or product name and P.C.P Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:** Carbaryl is a moderate reversible cholinesterase inhibitor. Atropine is antidotal.

**DISPOSAL:** Do not reuse empty container. Wrap empty container and discard in household garbage.
